## Further delay to publication of 26 March 2011 final prices

After receiving an application yesterday from Bay of Plenty Energy and Todd Energy for a further delay to the publication of final prices for 26 March 2011, the High Court has ordered a stay on the publication of these final prices pending a hearing on this matter on 16 August 2011.

#### **Review of UTS provisions**

At its meeting on 8 June 2011 the Board of the Electricity Authority requested staff prepare a Board paper reviewing the undesirable trading situation (UTS) provisions in the Electricity Industry Participation Code (Code). The Authority is disclosing this matter at this time to ensure all parties involved in the High Court's review of the Authority's recent UTS decision, are fully aware the Authority may propose Code amendments on this matter later this year.

The Board requested that the review consider differences between the UTS provisions that applied under the New Zealand Electricity Market (NZEM) rules and the UTS provisions in the Code, in particular relating to the test for when a UTS has occurred. Some aspects of the test were changed when the Electricity Governance Rules were made in 2003.

The Board noted the scope of the UTS provisions is restricted to the wholesale market for electricity, which excludes ancillary service markets, the electricity hedge markets and the retail electricity market. The Board requested the review also consider whether improvements can be made to the process requirements in Part 5 of the Code.



## Locational Price Risk/FTR initiative: Briefing

The Authority will shortly be releasing an information paper on its financial transmission right (FTR) initiative to address volatility caused by locational price risk.

A briefing to explain the initiative, including changes to the draft Code released for consultation in April 2011, will be held at the Authority, level 7, ASB Bank Tower, 2 Hunter Street, on Tuesday 2 August 2011 at 11.00am.

The Authority will also publish spreadsheets that provide more detail on the cost benefit analysis (CBA) contained in the consultation paper.

Under clause 16.7 of the Code each Rio Tinto party must, within 90 days of the end of the financial year, advise the Authority whether any acts or omissions have occurred during that financial year that may have been in breach of certain parts of the Code.
