This document notifies you that -

1. Mighty River Power Limited (Mighty River Power), a duly incorporated company having its registered offices at Level 14, ANZ Centre, 23-29 Albert Street, Auckland, gives notice that it intends to appear and be heard as a respondent in support of the final decision (Decision) of the Electricity Authority (Authority) on 15 June 2011 regarding the Undesirable Trading Situation (UT\$) of 26 March 2011 under Part 5 of the Electricity Industry Participation Code 2010 (Code), insofar as the Decision is challenged by the appellant, Genesis Power Limited (Genesis), and by Bay of Plenty Energy Limited/Todd Energy Limited and Contact Energy Limited in proceedings CIV-2011-485-1371 and CIV-2011-485-1372, and to oppose each such appeal, including on the additional grounds set out in para. 3 below.

2. Mighty River Power is:

- (a) an industry participant under the Electricity Industry Act 2010;
- a party that made a claim to the Authority that a UTS under the Code existed on 26 March 2011 as a result of the offer behaviour of Genesis on that date;
- (c) a party that was issued with statutory information requests by the Authority requiring it to provide information to the Authority for the purposes of the Authority's investigation of the UTS on 26 March 2011;
- (d) a party that was invited to, and that did, make written submissions and cross submissions to the Authority in relation to the Authority's investigation of the UTS on 26 March 2011; and

- (e) a party affected by the Decision of the Authority released on 15 June 2011 in which the Authority found that a UTS occurred on 26 March 2011.
- 3. The additional grounds on which Mighty River Power intends to support the Authority's Decision and oppose the appeals are that the Authority could also have found that there was a UTS on the basis of manipulative or attempted manipulative trading activity under clause (c)(i) of the UTS definition as a result of the Authority's findings that:
 - (a) Genesis squeezed the wholesale market for electricity (Decision, at paras. 132, 145, 156, 158); and
 - (b) Genesis offered its Huntly units at exceptionally high prices for the period of the grid outage while it had transitory market power (Decision, at paras. 107-109).

This notice is given under Part 20 of the High Court Rules.
