Electricity Industry (Exemption No. 161 (Contact Energy Limited)) Exemption Notice 2012

Pursuant to section 11 of the Electricity Industry Act 2010 ("Act"), the Electricity Authority gives the following notice.

Notice

- **1. Title and commencement**—(1) This notice is the Electricity Industry (Exemption No. 161 (Contact Energy Limited)) Exemption Notice 2012.
- (2) This notice comes into force on the day after the date it is notified in the *New Zealand Gazette*.
- **2. Exemption**—Contact Energy Limited ("Contact") is exempted from compliance with clause 10.3(b) of the Electricity Industry Participation Code 2010 ("Code") in respect of the following installation control points ("ICPs"):

- **3. Term**—This exemption expires at the earlier of:
 - (a) the date on which the Electricity Industry Participation (Metering Arrangements) Code Amendment 2011 comes into force; and
 - (b) the date on which Contact no longer has the responsibility in the registry as the trader for the ICPs listed above.
- **4. Reasons for granting the exemption**—The reasons for granting this exemption are:
 - (a) Contact would incur significant expenditure and complexity in fitting meters to each ICP where the loads are predominantly street lights and under-verandah lights with low annual consumption volumes (but over the 3,000 kWh level for unmetered load);
 - (b) the loads at these ICPs are static, have little annual variation, and changes can be accurately tracked;
 - (c) Contact has stated it will continue to treat the loads as standard unmetered loads and record the information in the registry;
 - (d) the ICPs are likely to comply with the new Part 10 threshold (6,000 kWh per annum) for predictable

- unmetered load when the new Part 10 comes into force;
- (e) the exemption will have little or no impact on other participants and service providers, and will not affect any other Code provisions; and
- (f) granting the exemption meets the requirements of section 11(2) of the Act.
