# **Distribution Pricing Principles and Information Disclosure Guidelines**

The Commission has published the Distribution Pricing Principles and Information Disclosure Guidelines. The paper finalises the draft pricing principles and information disclosure guidelines. The paper is designed to assist distributors in respect of the disclosure of information on their distribution pricing methodologies, and any subsequent review of the distributors' conformity with the pricing principles.

### **Distribution Pricing Administrative Issues Working Group**

A distribution pricing working group was formed in October 2009 to discuss a number of administrative issues relating to the interface between retailers and distributors. The group met twice in 2009 and produced a set of recommendations. In addition, members of the group prepared documents summarising:

- · file exchange and pricing used by distributors; and
- EIEP1 network reporting options.

The purpose of those two documents is to facilitate an understanding of subtleties of As Billed, As Billed Normalised and Normalised Data and to have a better understanding of billing complexities faced by some retailers.

# **AMI Working Group - call for nominations**

## Redclyffe 220/110kV Inteconnection Investment Proposal

On 11 February 2010, Transpower wrote to the Commission advising that it wished to defer the Redclyffe 220/110kV Interconnection Investment Proposal. Transpower advised that it will be conducting a trial at Redclyffe to investigate whether the capacity ratings of interconnecting transformers at specific sites can be increased without compromising system security.

Transpower expects that the trial will last for 12 months, after which Transpower will decide whether to proceed with the investment proposal, withdraw it or amend it.
