Electricity Authority impact of proposed Transmission Pricing Review changes on household electricity prices

The Electricity Authority released proposed changes to the Transmission Pricing Methodology guidelines on 17 May 2016. The potential impacts of this proposal on individual household consumers are outlined below.

The difference between the two figures relates to whether ACOT (avoided costs of transmission) payments continue or not. The Authority has proposed to remove the Distributed Generation Pricing Principles. This could alter who receives ACOT and how much is paid. In accordance with the Authority's proposal Transpower would make these decisions.
