Later, a new tenant moved into two of the floors and wanted to take supply from Genesis Energy. Accordingly we created the 2 new ICPs in question and advised the client and Genesis. <u>The</u> <u>meters/connections were electrically live throughout</u> , but we had to wait (quite some time) for the retailer to take up the ICPs and change them to Active before we knew what date to populate in the connection date so that the figure we entered was accurate (we did follow up).
