1. Introduction

- 1.1.1 The Innovation and Participation Advisory Group (IPAG) was formed by the Electricity Authority (Authority) in October 2017. The IPAG provides independent advice to the Authority on the development of the Electricity Industry Participation Code 2010 and market facilitation measures.
- 1.1.2 The IPAG focuses its advice on matters relating to evolving technology and business models, and competition and consumer choice. Specifically, under its <u>terms of reference</u> the IPAG can advise on:
 - a) initiatives to improve the efficient development and use of evolving technologies and business models across the supply chain, including reducing inefficient barriers to:
 - any consumers purchasing directly from the wholesale electricity market or directly from local generators
 - ii) mass-market demand response, and aggregators of mass-market demand response
 - iii) mass-market distributed energy resources, and aggregators of these resources, including distributed generation, batteries, micro-grids and 'prosumer' situations
 - b) initiatives to efficiently promote consumer participation through the whole supply chain, including:
 - i) improving consumer awareness, understanding, motivation and action by mass-market consumers
 - ii) increasing choices available to mass-market consumers by further enhancing competition
 - c) any other policy matters that the Authority considers appropriate.
- 1.1.3 The IPAG's terms of reference require the Chair to report annually to the Authority Board on the IPAG's progress against its work plan. This is the IPAG's first annual report, covering its activities from July 2017 to June 2018 (reporting period).
- 1.1.4 The only project on the IPAG's work plan in the reporting period was the *Equal* access project.

2. Work plan update

2.1 Equal access

- 2.1.1 The Authority asked the IPAG to consider and report on:
 - whether the operation of the existing equal access framework for transmission and distribution networks is sufficiently effective at promoting competition, efficiency and reliability for the long term benefit of consumers
 - b) potential options to strengthen the equal access framework to further promote competition, reliability and efficiency in the provision of electricity and electricity related services, including network support services

- c) the design, costs and benefits of any changes (regulations and/or market facilitation measures) identified to strengthen the equal access framework (including arrangements for exchange of network support services).
- 2.1.2 The project scope also allowed the IPAG to identify changes to strengthen the equal access framework by the Authority or Commerce Commission, or by amendments to the Electricity Industry Act 2010.
- 2.1.3 During the reporting period, the IPAG worked on developing a problem definition for the project.
- 2.1.4 To help inform its work, the IPAG:
 - a) sought input through the attendance of various stakeholders at its meetings (outlined in paragraph 4.2.2 below)
 - b) received written feedback from seven interested parties in April 2018 after issuing a *Market Brief* item calling for further views on potential concerns with equal access.

3. Chair's commentary on the performance of the IPAG and the secretariat

- 3.1.1 This is my first report to the Board as the Chair of the IPAG. In January last year, the Authority Board confirmed a decision to disestablish both the Wholesale and Retail Advisory Groups and to replace them with the IPAG, focussing on issues specifically related to new technologies, business models and consumer participation, and a Market Development Advisory Group (MDAG) focussing on further evolving the 'machinery' of the electricity markets.¹
- 3.1.2 In making this change, the Authority Board is acknowledging how the improving price-performance of new and, in particular, distributed energy technologies is enabling business models that step across the traditional wholesale-retail divide.
- 3.1.3 Our first project on *Equal access* recognises this new trend. Based on industry feedback to the Authority's 2017 discussion paper on Mass Participation, we have been tasked with reviewing the terms on which third parties can access electricity transmission and distribution networks both as users of the network service and as suppliers of inputs to those services.
- 3.1.4 The industry has given us a smorgasbord of issues to consider. This will be an interesting journey as the majority of the group's members are different from members of the legacy Wholesale and Retail groups with backgrounds in telecommunications, software development and sales, marketing and even engineering.

- 3.1.5 The group is also unusual in having an observer from the Commerce Commission. Not only are emerging technologies blurring the boundary between retail and wholesale, but they are doing the same for the distinction between the natural monopoly lines businesses regulated by the Commission and the markets regulated by the Authority.
- 3.1.6 Even our directions from the Authority Board have broken new ground rather than restricting our work to approved projects from the Authority's annual plan, we were invited to provide some independent thinking as an input to the Board's annual planning process in September this year.
- 3.1.7 My thanks to the Secretariat for their support of our work and to all the group members for their positive approach to this new group.
