## OIA request - TPM cost benefit analysis and terms of reference

I refer to your letter dated 2 September 2019, in which you requested the following information:

- 1. Who prepared the cost benefit analysis that forms the basis of the 2019 TPM Issues paper
- 2. If prepared by an external firm, the terms of reference (excluding financial matters)
- 3. Did the Authority have the CBA work peer reviewed?
- 4. If so, the documents that form that review.

We have assessed your request in accordance with the Official Information Act 1982 (OIA).

To answer your questions in turn:

- 1. The CBA was prepared by Strata Consulting Limited, in partnership with Sense Partners Limited
- 2. The terms of reference are the description of services specified in the contract between the Authority and Strata Consulting Limited. The relevant extracts from the contract and the variations to the contract, are attached.

## 3. Yes.

- 4. The CBA was carried out in three phases:
  - recommendation on the high-level methodology
  - elaboration on the CBA methodology/methodologies that would be used and identification of the expected inputs, assumptions, sensitivities, and scenarios that will be required
  - substantive analysis and compilation of the CBA.

## We had the CBA reviewed as follows:

- Advisian (Worley Parsons NZ Limited) reviewed each of the three phases
- Brian Bull checked the detailed workings of the CBA (phase 3)
- Electricity Authority internal staff, including those with experience in CBAs and in the Python and R programming languages, also carried out a peer review (at phase 3). This included reviewing the programming code and the output data relating to the power system (eg, demand, generation, energy flows to and from batteries).
