0	This right is subject to the Conditions 1,3,4,7,8,11 as per attached schedule.
1	The Grantee shall exercise this permit in conjunction with all other rights which the Grantee holds in connection with the generation of electricity within the Waitaki River system, in such a manner as to minimise , as far as possible, any adverse effects of the exercise of the rights on the Waitaki River system.
3	The Grantee shall measure and record the rate at which water is discharged, at a frequency not less than every 30 minutes, to the satisfaction of the Canterbury Regional Council, and the records supplied to the Council annually.
4	The Grantee shall erect and maintain signs warning of the danger of the fluctuations in the river/lake level at points of public access to the river/lake between Waitaki Power Station Tailrace and the immediate area downstream of the tailrace, to the satisfaction of the Canterbury Regional Council.
7	The Grantee shall:a) take such precautionary measures which the Canterbury Regional Council may require to prevent damage from erosion which is likely to occur as a result of the exercise of this permit; andb) make such remedial repairs which the Canterbury Regional Council may require to remedy damage from erosion which occurs as a result of the exercise of this permit.
8	The Grantee shall manage and operate spill flows in accordance with the provisions contained in "Waitaki Power Stations, Appendix A, Extracts of Waitaki Operating Rules (9 November 1990) as modified by an order pursuant to section 122 of the Electricity Industry Act 2010" (attached).
11	The Grantee shall give at least 24 hours notice to the Canterbury Regional Council of the intention to exercise this permit whenever the combined discharge of spillway, turbines and sluice gates will be greater than 850 cubic meters per second and shall advise as soon as practicable after incrementing each flow step as stipulated in "Waitaki Power Stations, Appendix A, Extracts of Waitaki Operating Rules (9 November 1990) as modified by an order pursuant to section 122 of the Electricity Industry Act 2010" (attached).
