Subject Upcoming amendments coming into force on 1 February 2020: Operational review of metering and related registry processes

For your information

The Electricity Authority (Authority) has decided to amend the Electricity Industry Participation Code 2010 (Code) to make a number of improvements to the Code. The amendments will come into force on 1 February 2021

These improvements stem from the Operational Review of Metering and Related Registry Processes, which we consulted on in the last quarter of 2018. Table 1 lists each of the 28 Code amendments (with reference to the proposal number in the decision paper), which participant types are affected and the clauses that have been amended.
