Doug: Have also copied to David Thomas S9(2)(a)

, the Project Director for the Renewable Electricity Generation Project being undertaken, for the first 4 listed MEUG members above. David can discuss the conceptual and commercial rationale for the project but cannot discuss the state of confidential commercial negotiations. David chaired a panel on Power Purchase Agreements at Downstream this year that I thought gave a very good overview of such arrangements. David may have a copy of that presentation.

Am not aware of other MEUG members that have in the past considered large scale co-gen or other larger dedicated generation

such as wind turbines on land they own.
Many members have small standby diesel gen sets and or
arrangements to access those when there are supply disruptions, e.g.
Countdown supermarkets and some of those listed above.
Some members may also have been looking at PV and or batteries,
though scale would be small. Not aware of any but not to say some
have been looking at it or implementing.
