

- Thanks for asking Ralph to pass on the attached MEUG briefings. I'm unclear whether the Authority still intends to respond to my OIA request or if the implication is that these briefings are everything in scope of the request and therefore no further response is required? In addition to the original request, we'd also like to know whether MEUG representatives met with Authority staff and/or Board members on each of these briefing dates – 23 April 2021 and 30 July 2021 – and who was at those meetings.
- 2. Following up on our phone conversation of Friday last week, I'd also like you to reconsider meeting with Meridian representatives to discuss the reduced thermal commitment seen in the last couple of years and the impact that has on the way that hydro offers are developed to manage storage and security of supply. If the Authority's position is still that it will not meet with or hear from us, could you please confirm that in writing? A refusal to meet and discuss anything that might in some way be linked to the broadly-scoped wholesale market review would be disappointing, especially in light of:
 - the attached information which clearly shows the Authority has already engaged in multiple conversations over a period of months with some participants on a topic the Authority has itself directly linked to the review in the Market Brief of 31 August 2021; and
 - the fact that reviews under section 16(1)(g) of the Act occur regularly and have not in the past prevented participants engaging with the Authority.

Llook forward to hearing from you and would be happy to discuss timing if the Authority is open to meeting with us.
