## 1.4 Electricity Industry Amendment Bill

1.4.1 On 9 September the government introduced the Electricity Industry Amendment Bill into the house. It is intended to give effect to certain recommendations from the Electricity Price Review. The Bill makes some significant changes to the Electricity Industry Act 2010 which will, if enacted, impact on the work of the Electricity Authority.

#### 1.4.2 The main changes are to:

- Establish a Small Electricity Consumers Agency, similar to EECA.
- Give the Authority a new objective to protect the interests of domestic and small business consumers, and a related new function.
- Delegate to the Authority the responsibility for developing the "arm's length rules" (transferring the rules into a new Part 6A of the Code) and allowing the Authority to regulate non-participants for this purpose.
- Giving the Authority explicit jurisdiction to require a distributor and other industry participants to enter into a distribution agreement on prescribed terms, and clarify that the Authority has jurisdiction to regulate for quality standards, provided they are within the context of the terms and conditions of access to the distribution network.
- Giving the Minister power to directly amend the Code if certain EPR recommendations have not been satisfactorily addressed.
- Enable the Authority to share information with other public service agencies or statutory entities.

# 1.5 Energy Hardship expert panel members named, and reference group established

- 1.5.1 The government has announced the membership of the expert panel, with nominees for the reference group still being considered.
- 1.5.2 The objective of the expert panel is to recommend to government, policy priorities and actions to alleviate energy hardship, and provide impartial, evidence-based expert advice. The Panel's work programme will in part, be drawn from the Electricity Price Review's findings and the government's response to its recommendations. Their work programme will be determined after the panel has convened.
- 1.5.3 The role of the reference group is to provide a forum to share information and encourage coordination across industry, NGOs and government agencies. The Group will help government work with others to shift the dial on energy hardship.
