#### **Customer Compensation Scheme Code amendment**

The recent Code amendment by the Authority that implements a customer compensation scheme came into effect on 1 April 2011.

The scheme will apply during any future official conservation campaign, such as may be required during extreme dry winter hydro storage conditions. Key provisions of the scheme include a clear definition of when official conservation campaigns are to be triggered and ended, and requirements for retailers to implement a compensation scheme for the benefit of their qualifying customers.

The Authority is publishing the 2011/12 draft policy statement in accordance with clause 8.12(1) of the Code and it is being provided to participants for their information at this stage.

As the current policy statement is incorporated by reference in the Code, the Authority will publish a formal regulatory statement in the first week of May for the purpose of consultation on proposed code amendments included in the 2011/12 draft policy statement and at such time submissions will be sought.
